SUBJECT: 2025 Foster Parent Cost of Living Allowance Increase

This memo is to provide guidance to regions and Community-Based Care Lead Agencies (Lead Agency) regarding the statutorily required foster parent Cost of Living Allowance (COLA), effective January 1, 2025, for Level I-V foster parent pursuant to section 409.145 (3)(b), Florida Statutes (F.S.).

During the 2013 legislative session, the Florida Legislature passed section 409.145(3), F.S., which establishes base room and board rate payments to foster parents and requires foster parents to receive an annual cost of living increase equal to the percentage change in the Consumer Price Index (CPI) for All Urban Consumers, U.S. City Average, All Items, not seasonally adjusted, or successor reports, for the preceding December compared to the prior December as initially reported by the United States Department of Labor, Bureau of Labor Statistics.

Effective January 1, 2025, the room and board rates to foster parents is adjusted as follows:

Age Range	2024 Room and Board Rate	Room and Board Rate Effective January 1, 2025
Zero to Five $(0-5)$	\$570.36	\$586.90
Six to Twelve (6 – 12)	\$584.98	\$601.94
Thirteen to Twenty-one (13 – 21)	\$684.70	\$704.56

Effective July 1, 2022, lead agencies shall pay a supplemental room and board payment to foster parents, and relative and nonrelative caregivers who are participating in the Relative Caregiver Program (which includes Nonrelative Caregiver Financial Assistance). Pursuant to s.409.145(3)(d), the supplemental payments are for the purpose of providing independent life skills and normalcy supports to children placed in their care who are 13 through 17 years of age. For 2025, the supplemental monthly payment is \$70.46, which is based on 10 percent of the monthly room and board rate for children 13 through 21 years of age.

Section 65C-16.013(8), Florida Administrative Code, outlines that a lead agency can negotiate a Maintenance Adoption Subsidy (MAS) up to 100% of the statewide foster care board rate. Based on

the 2025 foster parent cost of living allowance increase, a lead agency will now be able to approve MAS amounts up to the above mentioned updated statewide foster care board rates. Any rate over the 2025 statewide foster care board rates must be approved by the Department's Regional Community Directors.

Section 65C-44.003(9), Florida Administrative Code, outlines that a lead agency can negotiate a Guardianship Assistance Program (GAP) payment up to 100% of the statewide foster care board rate. Based on the 2025 foster parent cost of living allowance increase, a lead agency will now be able to approve GAP amounts up to the above mentioned updated statewide foster care board rates. Any rate over the 2025 statewide foster care board rates must be approved by the Department's Regional Licensing Office.

As of January 1, 2025, all Level I-V foster parents previously receiving a 2024 room and board rate in the amount of \$570.36, \$584.98, or \$684.70, for the child(ren) in their care must be paid the increase as specified in section 409.145(3), F.S.
